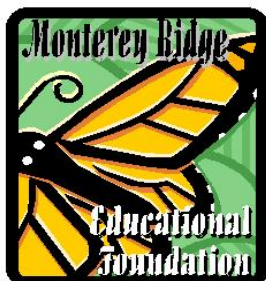

VISION

Students attending Monterey Ridge Elementary School (MRES) should experience the best quality of education we can facilitate. Given the additional budget cuts by the state and the district, as well as, new and exciting technology opportunities, we are asking for your help.

GOAL
